Helpful Information for District 1 Residents...

Culvert Installation

A culvert is a drain or pipe that allows water to flow under a road, railroad, trail, or similar obstruction from one side to the other. Most homes have culverts running underneath their driveway. If you are having drainage issues, you may need to have your culvert cleaned out or replaced.

To install or replace a culvert, please call District 1 office at **(918) 789-2279** so we may evaluate your current situation and determine the appropriate size and type of culvert for your property needs. You are responsible for purchasing the culvert, but there is no charge to the homeowner for the installation.

When you have purchased the culvert, call the District 1 office, and we will process a work order to pick up the culvert from a local retailer and install it with necessary gravel. Allow two to three weeks for installation.

Dirt

From time to time, landfill/construction grade dirt containing rocks, trash, and/or other debris maybe available. If you are in need for this type of fill dirt, then please call District 1 office to be placed on a waiting list. We must be able to reach you when a load becomes available in your area. The waiting list can be very long or short, depending on the current county projects.

Solid Waste Disposal Program

This is a year-round program offered to residents of District 1. The goal is to provide a service for District 1 residents by offering dumpsters in convenient places to dispose of solid waste. The Solid Waste Disposal Program is funded by a combination of tax revenues, grant funding, and income received from our Metal Recycling Program. Your help is essential in maintaining both of these programs. You will be required to provide your driver's license showing your address is located within Rogers County. Please note that this is a service for Rogers County residents only; not commercial operations.

We Gladly Accept:

Furniture, mattresses, carpeting, home remodeling debris, large household items regular trash service won't pick up, appliances with refrigerants or CFCs removed, yard and tree brush.

We DO NOT and CAN NOT Accept:

Household garbage, paint, batteries, caustic chemicals, oil, car & light truck tires *with rims removed*, tractor tires, dead animals, caustic or hazardous materials *of any kind*, materials containing asbestos, cylinders or other containers of compressed gas, containers with oil, gasoline, diesel fuel, hydrocarbons, or any other problematic products.

Please note that District 1 will accept car and light truck tires with rims removed and batteries during **Rogers County Trash-Off, which typically occurs semi-annually in April and October.*
