1. Discussion with possible action on Approval of Employee Benefits on medical, dental, vision, life and EAP Renewals for 2009 –

Cindy Giddings with CommunityCare presented the insurance benefits package and stated that the rates have stabilized and renewal rates can be reduced from 12% to 6%. Compared to the plans offered by the state, CommunityCare has richer benefits on the HMO plan and the premiums are less.

Chairman DeLozier inquired about the life insurance on retirees spouses, how come they can't keep that? Rebecca Vonfeldt, with Employee Benefit Professionals, LLC, replied that they have gone out to several insurance companies and we are not to find a company that will insure spouses on retirees. The retirees can cover the additional life insurance, but all the other companies declined the option to allow the spouses to continue on the retirees life insurance. It would be better for them to have their own life insurance and have whole life over term life insurance.

Delta Dental will have no rate increases and the coverage includes implants, the states plan does not offer implants. There is no increase in vision for 2009.

Terry Stover with EAP Program stated that 3 people had utilized the program in person and 11 were serviced by telephone over the last year. EAP is an OSHA issue, dependents or anyone are under their roof. Rogers County also needs to do more training on this program.

Commissioner Thacker made a motion to approve. Commissioner Helm seconded the motion. Roll Call: DeLozier-aye, Helm-aye, Thacker-aye. Motion carried.
