Commissioner DeLozier made a motion to approve the minutes from October 18, 2010, as presented with Commissioner Helm seconding the motion. Roll Call: Thackeraye, DeLozier-aye, Helm-aye. Motion carried.

ITEM 9: ROADS AND BRIDGES:

1. Discussion with possible action regarding Approval/Disapproval payment of Invoice to Oklahoma Department of Transportation, Comptroller Division, 200 N.E. 21st Street, Oklahoma City, Ok 73105-3204 – in the amount of \$2,054.14 for the 2009-2010 bridge inspection project State J/P No. 12996(12) and which fund to pay from - (D#2)

Commissioner Helm explained this invoice is related to the bridges ODOT inspected in July 2010; 80% of the costs were paid by federal fund amounting to \$8,216.58; Rogers County has to pay the remaining 20% of \$2,054.14.

Commissioner Helm made a motion to approve payment of Invoice to Oklahoma Department of Transportation in the amount of \$2,054.14 for the 2009-2010 bridge inspection project State J/P No. 12996(12) from fund 105 CBRIF with Chairman Thacker seconding the motion. 2. Discussion with possible action regarding Approval/Disapproval Oklahoma Department of Transportation Federal Emergency Relief Project Damage Statement on State Job/Piece #25524(04) at Winganon Crossing over Oologah Lake on county road EW/320 replacing rip rap on north side of road when flood waters has eroded embankment in the amount of \$39,341.00 (D#1)

Commissioner DeLozier stated this is an ongoing ER project on Winganon Crossing; another embankment has eroded while we are waiting for the engineering to be done in order to be able to replace the entire embankment; anytime District #1 has to do work on the embankment, District #1 can be reimbursed through ODOT, which comes from federal highway. Woolever, 2194 South 4190 Road, Chelsea, Ok 74016 — boring county road NS/4190 (northwest to southwest) located in the SE/4 of the NW/4 of the NW/4 of Section 7, Township 24 North, Range 17 East of the I.B.&M., Rogers County, Oklahoma — (D#1) Commissioner DeLozier stated he reviewed the location of this permit; it is to put in a new water line and is a bore only. 2. Cox Communications, 11811 East 51st Street, Tulsa, Ok 74146 – street bore North 145th East Avenue between East 110th Street North and East 110th Place North, located in Section 16, Township 21 North, Range 14 East of the I.B&M., Rogers County, Oklahoma – (D#2)

Commissioner Helm stated they contacted Cox Communications to let them know North 145th East Avenue is the dividing line between Tulsa County and Rogers County and the street is maintained by Tulsa County; informed Cox Communications a utility permit needs to be sent to Tulsa County also; and since they have come over into the county's ditch, we have asked them to continue to meet the conditions and requirements, that before placing a utility facility on any county right-of-way, a permit must first be obtained, using the standard form furnished by Rogers County. Chairman Thacker made a motion for Earl Hensley, maintenance department supervisor to be a non-exempt employee who will receive comp time in lieu of overtime and his monthly pay will be raised to \$3348.00 per month effective November 1, 2010, with Commissioner DeLozier seconding the motion. Chairman Thacker stated the non-exempt status come from Fact Sheet #17A from the U.S. Department of Labor Wage and Hour Division that was discussed with legal counsel in Executive Session.
