ITEM 1: CALL TO ORDER:

Chairman Dan DeLozier called the meeting to order at 9:00 a.m.

ITEM 2: ROLL CALL TO ESTABLISH QUORUM:

1. Amended Resolution #2011-80 Approving County Commissioner District Boundaries - ***NOTE***this item was originally approved on August 22, 2011***

Chairman DeLozier reported the district boundaries need to be amended because there was a small area on the Mayes/Rogers County line north of Highway 20 that was discovered when being mapped that left out around seventeen (17) houses; District #1 will pick up these seventeen residences and the population will change for District #1 = 28,671 and District #3 = 29,092; District #2 = 29,142 will remain the same.

Craig County Water District #2 – boring county road 350 located between Sections 25 & 36 of Township 24 North, Range 18 East of the I.B.&M., Rogers County, in District #1 Chairman DeLozier reported the utility permit does not reflect the manner of installation; DeLozier has reviewed and installation is boring only. Chairman DeLozier made a motion to approve with Commissioner Thacker seconding the motion. Roll Call: DeLozier-aye, Helm-aye, Thacker-aye. Motion carried.

A T & T trenching & boring starting approximately 1000 feet South of State Highway 66 and State Highway 28A, East on Third Street approximately 335 feet; place a 48 fiber optic East on North side of Third Street to Maple (South 4210 Road); then North on West side of South 4210 Road approximately 275 feet; then East to cell tower located in Section 32, Township 23 North, Range 17 East of the I.B.&M., Rogers County, in District #1 –

A. Update by Program Management Group, LLC (PMg) for Courthouse and E911 Center Projects –

Vernon Hawkins with PMg reported poured 2nd pour of the basement walls on Wednesday, August 31, 2011, (45% complete); no major material receipts during the week, other than concrete; French drain completed; this will plans are to pour 3rd pour of the basement walls; form and pour 4th segment; start waterproofing of basement walls; start backfill; complete form and pour of basement walls, waterproofing & backfill; pending changes are PCO #4 Sump pit for basement pending Architect's review and approval; PCO #5 delete door #1X119B in development by CM and PCO #6 Geothermal wall sleeves and piping sleeves in basement walls; no delays this week, project is on schedule. Update only, no action taken.

B. Update from Oklahoma Emergency Management, Dee McGee, regarding FEMA – (D#2 Helm)

Dee McGee and Kathleen Shingledecker with Oklahoma Emergency Management Office (OEMO) in Oklahoma City were present at the meeting; Commissioner Helm stated he asked them to be present to help explain the alternate project that gives District #2 \$13.5 million dollars from FEMA; we are currently in the middle of the county budget and have gone out for bids that were awarded last week; Commissioner Helm continued that none of these bids and roads that is being done in District #2 will impact the county whatsoever; now we have heard from OEMO that funds the county was to receive from FEMA are now on hold.

Shingledecker, Public Assistance Officer, reported at this time there is no county money whatsoever being used for these projects; because it is an alternate project that deals with Keetonville Road; Keetonville Road cannot be repaired, which is why an alternate project was conceived; it has come to the point where this alternate project was put down in final in our project worksheets; on August 27, 2011, FEMA came in with immediate needs funding and have shut down all funding, except for Category A (debris) and Category B (emergency protective measures); Keetonville Road is considered a permanent project, and at this point FEMA will not fund it; that does not mean it will not be funded in the future.

Commissioner Helm stated District #2 asked for bids on this project per Dave Woodam's recommendation and stated FEMA guidelines were followed; vendors are present today so they understand Rogers County funds will not be used; funds will come from FEMA, but right now there is a delay.

Assistant District Attorney, David Iski, asked for a written report from OEMO to help gauge for budgeting purposes. Discussions only, no action taken.

C. South Missouri Street Courthouse employee over-flow parking lot area to be fences off for staging area for Rogers County Courthouse Building Project during duration of Project – (D#3 Thacker) - ***NOTE***this item was tabled from August 22, 2011, meeting***

Chairman DeLozier reported county now has obtained another staging area and will proceed with fencing them off now. Discussion only, no action taken.

D. County 2011-2012 Estimate of Needs (budget) and Financial Statement of the Fiscal Year 2010-2011 – (D#1 DeLozier)

Chairman DeLozier reported the budget was been ready for about three (3) weeks, but it needs to be determined if the county needs to come up with extra money for the courthouse project; does the county need to hold some money back or can it be given to the offices requesting extra this year. Item stricken from agenda until further notice.

Jerry Smittle with the Sheriff's Office explained they wanted to go with Preferred Business Systems because they are \$100 per month cheaper; also allows to fax, e-mail and scan, which in turns saves approximately 1100 pages; currently we are spending anywhere from \$400 to \$800 for overages every quarter; this will be approximately \$5,000.00 savings and recommends the Board approve.
