ITEM 1: CALL TO ORDER: Chairman DeLozier called the meeting to order @ 9:03 a.m.

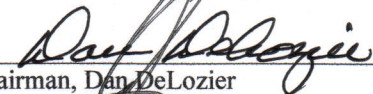
ITEM 2: ROLL CALL TO ESTABLISH QUORUM:

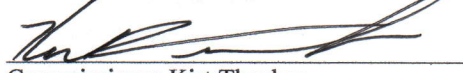

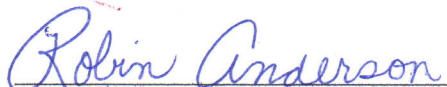

1. RWD #3 Rogers County – To Bore – Cross County Highway or Local Road 177th E. Avenue, approximately 0.344 miles south of 96th Street North & 177th E. Avenue junction and further described as: 1,815 feet south of the NE corner of Section 23, Township 21N, Range 14E, Rogers County, District #2 – (Curtis) Planning Commission Director Larry Curtis recommended approval of Utility Permit.
