2. Independent Contractor Agreement by and between the Board of County Commissioners and Reliable Services on behalf of the Court Clerk's Office – (Court Clerk) – Court Clerk Kim Henry reported that due to budget cuts in the court system, her office is now responsible for cleaning the secure areas for the Court Clerk's Office. After a lengthy discussion, Commissioner Helm made a motion to table for one (1) week for further review with Chairman DeLozier seconding the motion. Roll call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried.
3. Presentation by Utility Rebate Consultants – (DeLozier) – Gary Dennis, URC representative gave a brief presentation. They would be looking for refunds, rebates, and overcharges. He said his firm would audit utility meters and determine if rebates and or refunds were in order. To get started, URC would need one (1) months bills, authorization, and signed agreement. His company is not a fee based service. Savings for the first 24 months is split 50/50. Then 100% of the savings would go to the county. ADA David Iski asked what other government agencies he has worked with and for references. Commissioner Thacker made a motion to proceed with URC with Commissioner Helm seconding the motion.
