Public hearing with discussion and possible action on the request for zoning change from AG to RST-60 that the intended use of the property, after rezoning, is for Residential Lot Split & Single Family Manufactured Home. APPLICANT: Phil & Geoma Pennington. CURRENT ZONING: AG. LEGAL DESCRIPTION: East 309' of the North 704.85' of the W2 NW of Section 12 Township 22 North, Range 14 East of the I.B.&M., Rogers County, Oklahoma containing 5.00 acres more or less. ADDRESS: 3170 E. 4020 RD., Oologah, OK. 74053 – (Curtis)
Planning Commission Director Larry Curtis informed the Board this passed the Zoning Board with a 6/0 vote. He also stated property was north of 169 highway and not directly on the highway and recommended approval. Public Hearing was opened at 9:06 a.m. and there was no opposition present. Hearing closed at 9:08 a.m. Commissioner Helm made a motion to approve with Commissioner Thacker seconding the motion. Roll call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried.
2. Public hearing with discussion and possible action on the request for zoning change from AG to AR that the intended use of the property, after rezoning, is for Residential Lot Split & Single Family Residential. APPLICANT: Rod Henry Construction INC. CURRENT ZONING: AG. LEGAL DESCRIPTION: The S2 NW SE and the SW SE Less the South 660' of the West 665.0' Thereof, In Section 26 Township 23N Range 14E of the I.B.&M. Rogers County, State of Oklahoma, According to the US Government Survey thereof. GENERAL LOCATION: Vacant Land EW 400 Road between 4050 & 4060 Road, Oologah, OK 74053 – (Curtis)
Planning Commission Director Larry Curtis stated these were five (5) acre Lot splits. Minimum is 2.5 acres. He also said this passed the Zoning Board with a 6/0 vote. Commissioner Helm questioned any drainage issue and Director Curtis said these issues had been addressed. 
