ITEM 19: AGENDA ITEMS:

1. Update regarding E-911 Trust Authority (Thacker) - Janet Hamilton said a legal contract has been sent for legal review.
2. Discussion and possible action regarding the travel policy for Rogers County employees (Helm) –Jenny Bentley stated she and the County Clerk's office were firming up the travel policy. There were no changes, they just needed to be specific and put policy down on paper. Helm asked if there had been a problem and Teresa Jackson, First Deputy to the County Clerk, stated there hadn't been a problem, just questions raised and they needed an operating procedure to be approved by the governing board. Undersheriff Jon Sappington said Major Bob Darby and Chief Shane Rhames went to a training where they spoke to the State Auditor and Sappington recommended to the Board to send a copy of the policy to all department heads and table it for one week. Helm made a motion to approve the travel policy submitted by Bentley and Thacker seconded and asked Bentley to send out to all departments. Roll Call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried.
3. Review current three month and six month bid lists and their specifications (DeLozier) – DeLozier stated Purchasing Agent Megan Jackson is making out the three and six month bids and there are a few there that aren't being used anymore and there's no reason for them to be on the list. Helm stated there is a Felt bid missing from list and Jackson said she would look back and find it. DeLozier asked Jackson to get a list for the Felt and get it back on the bid list. DeLozier made a motion to strike Bid 15 – Grader Blades, Bid 16 – New Pipe, Bid 22 – Concrete Culvert Pipe and Bid 23 – Precast Concrete from the bid list and Thacker seconded. Jackson asked about reviewing the specifications for the bids and DeLozier responded they would do that later as they have time before the next bids go out. Teresa Jackson asked the bids that are to be sent should be on the agenda for the Board to review before they go out to vendors. DeLozier made a motion to review all bids before they go out. County Clerk Robin Anderson reminded DeLozier that no roll call was done for the previous motion to strike bids from list. Roll Call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried. DeLozier made a motion to review all bids before they go out. Roll Call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried.
4. Discussion with possible action regarding approval/disapproval of a Resolution 2015 - 77 accepting for and on behalf of Rogers County, Oklahoma, the beneficial interest in the trust created by the First Amendment to Amended and Restated Declaration of Trust of Rogers County Criminal Justice Authority (DeLozier) - Jim Orbison, Attorney for the Authority, stated the Rogers County Criminal Justice Authority is requesting to amend the Declaration of Trust to add the town of Verdigris and add the mayor of Verdigris as a trustee which makes Verdigris a beneficiary. Helm asked if they understood they were responsible for the stipend to which Orbison responded he could not say they understood it. DeLozier asked if they accepted beneficial interest and Orbison replied yes. Thacker made a motion to approve and Helm seconded. Roll Call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried.
5. Resolution 2015-76 and Reimbursement Form to 83ST-200 One Cent Sales Tax fund from Planning Commission Fuel Reimbursement \$589.57 – Thacker made a motion to approve and Helm seconded. Roll Call: DeLozier – aye, Helm – aye, Thacker – aye. Motion carried.
6. Discussion and possible action to enter executive session - Pursuant to Okla. Stat. Ann. tit. 25, § 307 (B) (4), for the purpose of confidential communications between a public body and its

attorney concerning a pending investigation, claim, or action if the public body, with the advice of its attorney, determines that disclosure will seriously impair the ability of the public body to process the claim or conduct a pending investigation, litigation, or proceeding in the public interest, to-wit: Material Services Corporation v Rogers County, Rogers County Case No. CJ-2004-234 – Mr. Rogers asked the attorney for the lawsuit if they made a recommendation to enter an executive session and he replied there was no executive session required.

7. Motion to vote to adjourn executive session and enter regular session – Not needed.
8. Discussion and possible action regarding executive session item to-wit: Material Services Corporation v Rogers County, Rogers County Case No. CJ-2004-234 – Attorney Tom Williams stated that last Wednesday they lost the case. They technically lost the case in 2006. Within the last month, they discovered Mr. Marler had filed with a petition from Begley to intervene in the case a complete copy of the lease. Two weeks ago, the other side of the Begley case gave Williams a copy of the deposition taken in 2006 by counsel for the commissioners of Mr. Begley involving the lease. It's hard to prove the lease was not disclosed when counsel for the commissioners had it in his hands in 2006. Williams recommends against any appeal.

Wilkens asked about the employee that was gifted time, asking who the employee was and if it was a resignation or termination. DeLozier responded it was neither.






