ITEM 18:

AGENDA ITEMS:

1. Update from CPA Bill Turner – Turner stated, through March 31, the general fund has collected, roughly, a little over 11 million dollars. It was budgeted at \$11,550,000.00 so we're within \$500,000.00. We should collect another million dollars from April 1 – June 30. We should wind up with excess collections based on that. Expenditures on the general fund are at \$8,881,000.00 and the budget is at \$12,164,000.00. Based on those numbers, we should be fine with getting us to June 30th. Helm asked if Turner saw any place we need to look at as far as where we may have a shortfall. Turner stated the ongoing issue was with the schools. Assistant District Attorney Ben Lepak stated one school has paid a partial amount since that hearing. Helm asked if that should be put on the agenda or under executive session and Lepak stated he wanted time to think about it. Helm asked if there would be a shortfall if we don't collect what we budgeted from the schools. Turner agreed. Helm asked if there would have to be an addendum to the budget and Turner stated they would be billed again. He added that everybody that participates with the collection of ad valorem taxes gets benefit from it. Burrows asked about the bond proceeds and asked if that dollar amount would have to be used. Turner stated he didn't believe we would. Burrows asked about the court fees. Turner stated we get reimbursed for those salaries. Helm asked Court Clerk Kim Henry if what the Supreme Court was doing would hurt her budget. Henry stated if they cut her budget, she'd lose employees. Helm asked if she would lose employees in the office or in the courts. Henry stated it would come from the courts and the judges know that. If her budget is cut, she would have to cut some employees. Henry added she didn't plan on asking the County to reimburse her. Lepak asked Turner if there is amount owed by the schools that

isn't collected in this fiscal year, the County still won't have a shortfall. Turner agreed that we could still meet our expenses but would have to have that money paid. Burrows asked how soon Henry would know about the budget and Henry stated June 15 was the latest she'd ever seen it come back. Helm stated these cuts were coming from the Supreme Court Justice, not the Court Clerk or the County. DeLozier asked if this was a yearly occurrence that she was told there would be cuts. Henry stated they've been told it's coming. No action taken.

2. Discussion and possible action regarding acquiring the Federal Building through the Department of Justice application or by purchasing the building from the General Services Administration (Burrows) – Burrows stated he was surprised there were options. Undersheriff Jon Sappington stated Larry Curtis knew more about it but what he knew was we couldn't concrete in the price and it was subject to the evaluation of the building. So if that building's value increases, she does the price. Sappington stated he felt a contract needed to be in place so they couldn't come back in five years and kick us out and capitalize on our improvements. Lepak asked for the contact info so he could contact them to get more answers and information. No action taken.

Note Returned to this item after Item 18:14. – Curtis stated that either way this is done, it's a deed situation. The application was for the Department of Justice to see if they got approved. The Sheriff's Office has done that and been approved. If the Board moves forward with one of the options – either purchasing it or going through the Department of Justice application, the deed will reflect that we own it outright or there will be a restrictive clause that reads that it can only be used for the Sheriff's office. There is no contract. Burrows asked what would safeguard us from losing it at the end of five years. Curtis stated as long as we keep up with the usage of the property, that won't happen. They will inspect every five years. Lepak asked if the county bought it outright, could they change the use of the building and Curtis agreed they could. Curtis added if there are improvements added to the building, a new appraisal would have to be done to reflect the improvements. If it's always used for the Sheriff's office, we wouldn't ever have to pay a dime. DeLozier asked Lepak to get with Curtis and get more information. No action taken.

Burrows stated this was his first bid and if they saw anything on the bid that looked incorrect, let him know. Burrows made a motion to approve and Helm seconded. Roll Call: DeLozier – aye, Helm – aye, Burrows – aye. Motion carried.

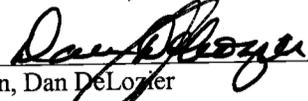
