4. Firm prices will be F. O. B. destination.
5. Purchases by Rogers County, Oklahoma are **NOT** subject to **State or Federal Taxes.**
6. This bid is submitted as a legal offer and any bid when accepted by Rogers County constitutes a firm contract.
