



Rogers County District 1 Commissioner Dan DeLozier

Dan DeLozier was elected to serve as Rogers County Commissioner by the citizens of District 1 in November 2006 and was re-elected in 2010, 2014, 2018, and 2022. He was born in Stillwater, Oklahoma to the late Captain Samuel Don and Barbara DeLozier, but was raised in Chelsea, Oklahoma with the help from his grandparents, Harlan and Lucille "McSpadden" DeLozier. He attended public school there, graduating from Chelsea High School. Besides growing up in Chelsea, Commissioner DeLozier raised his family there. He has been married to his wife Lisa for 45 years, has two sons, and three beautiful grandchildren.

Commissioner DeLozier has always dedicated himself to community service and began his service as a volunteer firefighter EMT with the Chelsea Fire Department for eighteen years; was a board member and coach of the Chelsea Summer Baseball League for nine years; and served as President of the Chelsea Booster Club for two years.

His professional experience prior to his election as Commissioner included serving as an elected representative for Office No. 5 on the Chelsea School Board. He was a superintendent for D&B Construction for twenty-eight years overseeing road and bridge construction projects, sanitation landfill construction, environmental waste projects, coal mining, and construction of subdivision roads and utility lines.

Commissioner DeLozier has focused on making county government more transparent and accountable with greater openness to bring positive economic growth and progress to Rogers County.
