

RESOLUTION NO. 2022-128

EMERGENCY RESOLUTION REGARDING FAIR BOARD ELECTION

PURSUANT TO AN EMERGENCY MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF ROGERS COUNTY, THE FOLLOWING EMERGENCY RESOLUTION WAS ADOPTED:

WHEREAS, on the 18th day of January, 2022, the Board of County Commissioners approved Resolution 2022-119 setting the filing period for the Board of Directors of the Rogers County Fair Board shall commence on Monday, January 31, 2022 at 8:00 a.m. through the close of business on Friday, February 4, 2022 at 5:00 p.m.

WHEREAS, OKLA. STAT. tit. 2, § 15-68(C)(1) requires that the filing period for the Board of Directors of the Rogers County Fair Board “shall consist of five (5) consecutive business days . . .”

WHEREAS, on Wednesday, February 2, 2022, the Board of County Commissioners of Rogers County held an emergency meeting to address the potential for inclement weather which could result in the closing of the Rogers County Courthouse for a portion of the filing period for the Board of Directors of Rogers County Fair Board.

WHEREAS, the Board of County Commissioners of Rogers County has determined that should the Rogers County Courthouse close for one or more full business days due to inclement weather, for each full day the Rogers County Courthouse is closed, the filing period for the Board of Directors of the Rogers County Fair Board shall be extended by that number of days, commencing on the next business day the Rogers County Courthouse is open to the public.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ROGERS COUNTY, STATE OF OKLAHOMA:


That should the Rogers County Courthouse close for a full day due to inclement weather, the filing period for the Board of Directors of the Rogers County Fair Board shall be extended by that number of days, commencing on the next business day the Rogers County Courthouse is open to the public.

Notice is hereby given by the Board of County Commissioners, that the election of Directors of the Rogers County Fair Board shall be held on **Saturday, February 26, 2022 at 10:00 A.M.** at the following locations:

District #1 – County Warehouse, 6105 S. Industrial, Chelsea, Oklahoma

District #2 – County Warehouse, Oologah (One-mile West of Intersection of Hwy 88 and Hwy 169)

District #3 – Rogers County Courthouse, First Floor Commissioner’s Meeting Room

The filing period for said election shall commence on Monday, January 31, 2022 at 8:00 A.M. and end at the close of business on Friday, February 4, 2022 at 5:00 P.M.

THE FILING PERIOD WILL BE EXTENDED ONE DAY FOR EACH FULL DAY THE COURTHOUSE IS CLOSED

i.e., If the courthouse is closed on Thursday, filing period will end Monday, February 7, 2022 at 5:00 pm, if the courthouse is closed both Thursday and Friday, the filing period will end Tuesday, February 8, 2022 at 5:00 pm


Only registered voters of Rogers County shall be eligible to file as a candidate.

Any person so filing must reside in the Commissioner’s District or City they seek to represent.

Prospective candidates must file with the County Clerk on the form prescribed by the Board of Commissioners of Rogers County.

Those persons wishing to file shall file on the prescribed form which may be obtained from the office of the Rogers County Clerk **Monday-Friday, between the hours of 8:00 A.M. and 5:00 P.M., at the Rogers County Courthouse, 200 S. Lynn Riggs Blvd., Claremore, Oklahoma.**
