TOPIC: For the Purposes of Closing Out a Community Development Block Grant for Economic Development Infrastructure Financing Project #17140 and #17147 CDBG ED 17 on behalf of the Rogers County's Sofidel America Economic Development Project

A second and final public hearing for the Rogers County's Sofidel America's Economic Development Infrastructure Financing Project #17140 and 17147 CDBG ED 17 will be held on February 22, 2021 at 9:00 A.M. at the Commissioners' Meeting Room, 1st Floor, Commissioners' Meeting Room, 200 South Lynn Riggs Blvd., Claremore, OK. The purpose of this public hearing is to provide the citizens of the Rogers County an opportunity to receive information on the County's performance in implementing the Oklahoma Department of Commerce Community Development Block Grant Economic Development Infrastructure Financing (CDBG-EDIF) **program and federal funding award of \$1,300,000.00 to assist Rogers County in providing infrastructure improvements in the extension of water distribution to accommodate the manufacturing and distribution facility of Sofidel America that provided for the creation of 233 jobs with 130 of those positions provided to low-to-moderate income families as tracked and reported. Of this grant award, only \$764,217.51 was expended due to costs savings during construction. The CDBG program was matched with funding provided by the US Dept. of Commerce's Economic Development Administration (EDA) program funds expended in the amount of \$592,835.59. Non-federal or private funding in the amount of \$360,000,000 was provided for a total project cost of \$361,357,052.31 in combined efforts.**

This public hearing is open to all citizens of Rogers County who are invited to attend and provide comments on the County's performance regarding the implementation of the above-named project. Written comments should be sent to County Clerk, 200 S. Lynn Riggs Blvd., Claremore, OK 74017 prior to the above date.
